**School board closes meeting for hypothetical purpose**

The Warren County School Board closed its meeting on Tuesday, Sept. 24, for a hypothetical purpose, a move that could lead to potential litigation, according to a legal expert.  
The board, which meets on the second Tuesday of each month, closed its meeting at 7:30 p.m. on Tuesday, Sept. 24, after a 10-minute session. The board had been discussing a potential lawsuit filed by a parent against the school district. The lawsuit, filed in Warren County Superior Court, alleges that the school district violated the state's Freedom of Access to Clinic Entrances Act (FACET) by denying access to a school building to a parent who is wheelchair-bound.
